Program Highlights

Cooperative Fire Protection

The lowa Department of Natural Resources delivered wildland fire courses to 500 students, funded 5,129 acres of hazardous fuels, and supported Federal wildland fire suppression efforts through the mobilization of firefighters and equipment. Additionally, the state implemented hazardous fuels reduction projects and 50 wildfire prevention education programs. Through State Fire Capacity and Volunteer Fire Capacity, 110 fire departments were supported with grant funding.

Economic Action

In 2024, one lowa project received \$29,950 in the Forest Markets' grant funding for the Temporary Bridge Crossings program.

Forest Health Protection

Emerald ash borer has been confirmed in all 99 counties and is causing significant ash mortality in portions of the state. Iowa forests continue to be affected by weather events, including statewide drought in 2023. Over 6,500 acres were impacted by white oak mortality in 2023. Threats to oak health continue to be oak decline, oak wilt, and bur oak blight. So far, the Slow the Spread Program for spongy moth has prevented oak defoliation by this pest.

Forest Stewardship

In addition to providing onsite technical assistance, the other pillar of Iowa's Forest Stewardship Program is delivering broad education, outreach, and awareness to Iowa's 138,000 private forest landowners across the state. In that spirit, 2024 saw the release of 31 short videos aimed at providing technical forest management topics directly to landowners. The "Forest Landowner's Toolkit" video library, a collaborative effort between the Iowa Department of Natural Resources and Iowa State University, was funded thanks to a USDA State, Private, and Tribal Forest Service mini-grant and produced by local videography firm, Bottlesode Films. The succinct, Iowa-centric, and often humorous videos have garnered over 2.2k views in their first six months

The lowa Department of Natural Resources operates one State nursery, located in Ames on the campus of lowa State University. Through the Forest Stewardship program and National Reforestation, Nurseries, and Genetics Resource program, the State receives financial assistance to support nursery, genetics, and seed programs. Funds helped to add a corn-cob storage facility at their state nursery in Ames.
