State, private, and other non-Federal forests make up 92 percent of the 176 million acres of forests across the 20 states of the Northeast and Midwest. The U.S. Forest Service and state forestry agencies collaborate with other partners on shared stewardship goals, which also support each State Forest Action Plan. The State and Private Forestry programs promote the health, resilience, and productivity of trees and forests across all ownerships for the benefit of people and wildlife; establish and manage urban and community forests; empower private landowners with information and technical assistance to sustainably manage their forests; and protect critically important rural forests and watersheds.

- Conserve and manage working forest landscapes for multiple values and uses.
- Protect forests from threats.
- Enhance public benefits from trees and forests.

- Grow forests, habitats, markets, and jobs.
- Manage forest health and fire.

## Program Highlights

### ***Chesapeake Bay Initiative***

Maryland is a leader in the Chesapeake Bay Program's Forestry Workgroup, advancing forestry goals included in the Chesapeake Bay Watershed Agreement and the Natural Filters Restoration Program through a partnership of the Maryland Department of Environment and the Maryland Department of Natural Resources. Maryland maintains and conserves riparian forest buffers through the Backyard Buffer program and the Stream ReLeaf program, especially (for the latter) in Fredrick County, which serves as a model for using local stormwater funds to plant and protect trees on private property. Maryland continues to address forestry goals that are part of the Chesapeake Bay Program and State Watershed Implementation Plans and worked on a Chesapeake Bay Shared Stewardship Agreement signed by State Foresters and the USDA Forest Service Chief in October 2020.

### ***Cooperative Fire Protection***

Maryland was awarded a competitive State Fire Assistance grant to mitigate risk in wildland urban interface areas through the delivery of 40 wildfire prevention and mitigation outreach events; treatment of 460 acres in 30 fuels reduction projects; recertification of four Community Wildfire Protection Plans and development of four new ones; and the upgrade of a fire weather station to support fire-adapted communities. Maryland acquired \$1,163,128 in property from the Department of Defense Fire Fighter Program and \$139,018 in property from the Federal Excess Personal Property program. The property is used to support the State and Volunteer Fire Department wildland fire programs.

### ***Forest Health Protection***

The Maryland Department of Agriculture, Forest Pest Management, released over 12,600 parasitoids to emerald ash borer (*Oobius agrili*, *Spathius agrili*, *Spathius galinae*, and *Tetrastichus planipennis*) on State lands, one arboretum, and one Nature Conservancy property; and, in conjunction with the Maryland Department of Natural Resources and Conservation Corp, also treated 92 ash trees. Over 3,000 hemlock trees were treated across State lands for protection against hemlock woolly adelgid. In 2020, 168 acres of high-value rural forest land were aerially treated for gypsy moth. The spotted lanternfly quarantine in Maryland currently includes Cecil and Hartford Counties.

### ***Forest Stewardship***

The Maryland Forest Service (MFS) is an advocate for landowners and their forests, working alongside landowner partners while educating them on how best to realize the potential of their land. No better resource exists to identify the many objectives needed to manage woodlands than the breadth of knowledge and field expertise found within the MFS. In 2020, a total of 30,971 acres were covered by new or revised stewardship plans on private lands. In collaboration with other forestry-related partners,

1,330 landowners were provided forestry technical assistance.

### ***Urban and Community Forestry***

Maryland Forest Service is increasing tree canopy through educational opportunities that provide new tools, targeting techniques and resources to motivated individuals to share with their communities. This effort is advanced through participation in the new Tree Campus Healthcare award, which recognizes the importance of the interaction of trees and health.
