Oklahoma Forestry Services' mission is to conserve, enhance, and protect Oklahoma's forests and natural resources for present and future generations. Oklahoma's cooperative forestry programs are administered by and implemented through a partnership between the State Forester, the USDA Forest Service, and many private, non-profit, and governmental entities. These programs promote the health, resiliency, and productivity of the state's forestlands and other natural resources to improve rural economies.

### Program Goals

- Reduce the risk and impact of wildfire in Oklahoma through prevention, improved detection and suppression, hazard mitigation, and increased capacity.
- Increase Oklahoma lands under active conservation management.
- Improve the overall health and diversity of urban forest resources through improved public education and collaboration with Oklahoma's communities.

### Key Issues

- Wildfire prevention and hazard mitigation is an increased priority for Oklahoma Forestry Services. The last several years have shown large increases in both wildfire occurrence and acres burned. Extreme risk from wildfire is ever present due to the severe droughts over the last decade that increased tree mortality while periodic wet spring seasons have added to the tremendous wildland fuel loading already present.
- Oklahoma landowners utilize active land management to promote long term protection, conservation, and utilization of forest land and resources. Current estimates reveal that Oklahoma has approximately 1.8 million forested acres under active management.
- Prescribed burning is one of the management tools used to increase health and resilience of Oklahoma's landscape. Careful application of prescribed fire where practical is used for hazardous fuels mitigation, increased resource benefits, and reduced wildfire impacts to natural resources and values-at-risk. Oklahoma Forestry Services conducts prescribed burns on public lands and provides technical expertise and training to promote prescribed burning in Oklahoma.
- Tree City USA is a community forest program designed to encourage healthy trees and forests within the boundaries of communities across Oklahoma. Currently, Oklahoma's Tree City USA communities serve 46% of Oklahoma's population. OFS will continue to invest in this program in order to increase the percent of population living in a Tree City USA.
- Eastern redcedar is encroaching on plant communities, degrading forest ecosystems (especially in the Cross Timbers region) and increasing wildfire risk. Reduced land management and increased cost for redcedar removal are primary reasons for this encroachment. Solutions to this problem

includes promoting active conservation management and developing markets to increase redcedar utilization.

## Program Highlights

### Conservation Education

Oklahoma Forestry Services is dedicated to fostering forest stewardship through comprehensive conservation education initiatives. Last year, we reached over 18,000 students through educational outreach programs, inspiring the next generation to appreciate and protect our forest ecosystems. Our Project Learning Tree (PLT) program, a cornerstone of our efforts, provided 25 workshops to train 371 educators with innovative tools and resources to teach students about forestry, conservation, and sustainability. Additionally, we manage the Forest Heritage Center in Broken Bow, Oklahoma, which serves as an educational hub for visitors to learn about the past, present, and future of forestry through interactive exhibits and engaging programming.

### Cooperative Fire Protection

Oklahoma Forestry Services continues to provide Fire Management programs for protection of lives, values at risk, and natural resources. OFS works with landowners, communities, State and Federal agencies and fire departments to collaborate on suppression, mitigation and prevention efforts needed to protect Oklahoma resources.

### Economic Action

Oklahoma Forestry Services has been working with and will continue to assist companies and groups to promote economic growth and benefits of wood products for Oklahoma. Information derived from the Forest Inventory and Analysis program is provided to all interested parties to aid in the economic development of forest industries.

### Forest Health Protection

Each year, Oklahoma Forestry Services flies over 800,000 acres of concentrated pine to monitor for damage and mortality caused by insects and diseases including southern pine beetle, Ips species, black turpentine beetle, and foliar fungal diseases. Working with other state agencies, private businesses, and the general public OFS runs a monitoring program for emerald ash borer. OFS also watches for other diseases and insect problems throughout the State, when a potential problem is identified action is taken in order to control the issue. In 2025 OFS plans on performing bio-control releases at multiple sites in southern Oklahoma in attempt to introduce parasitic wasps to decrease the establishing emerald ash

borer populations. Throughout these projects as well as other program areas OFS educates landowners on current and potential pests to Oklahoma's forested resources and provides technical assistance to promote resilient forests in current and future conditions.

### **Forest Legacy**

Oklahoma Forestry Services continues its partnership with The Conservation Fund to obtain the state's first State Forest through the USDA Forest Legacy Program. The Musket Mountain Forest project grant application ranked #5 of 20 Forest Legacy projects to be funded in federal FY25, putting it in good position to be fully funded. The Conservation Fund is helping OFS fundraise the remaining non-federal state match portion of the grant, receiving the first private donation for the project in January 2025. Fundraising efforts will continue with the goal for closing on the project in 2027.

### **Forest Stewardship**

Oklahoma Forestry Services is focused on helping private landowners manage their land. All management decisions are made with the landowners objective in mind, providing the needed prescriptions to achieve the landowners goals while protecting and enhancing the state's natural resources. The Forest Stewardship Program works closely with OFS's other programs to provide the technical assistance best suited to the landowner's goals.

### **Landowner Assistance**

Oklahoma Forestry Services primary task is to offer landowner assistance to help with any forest management needs they may have.

### **Landscape Scale Restoration**

Oklahoma Forestry Services is involved in working with established and potential partners to improve communication, increase technology, connect private contractors with landowners and to mitigate storm damage in communities. Some of our partners include USFS, NRCS, US Fish and Wildlife Service, Oklahoma State University, Oklahoma University, Oklahoma Department of Wildlife Conservation, Oklahoma Prescribed Burn Associations, and Oklahoma Forestry Association. OFS is continually looking to create new and strengthen existing partnerships.

### **Urban and Community Forestry**

Oklahoma Forestry Services continues to work with cities, towns and non-profits across the state to promote and improve the active care and management of forests and trees. Workshops and conferences are conducted throughout the year. Grants are offered for tree planning, planting and care.
